Recommendation/Motion: Approve the membership for the Local Planning Committee for the 2017-2021 plan cycle.

Background/Rationale: The Kentucky Department of Education in its Facilities Planning Manual (701 KAR 1:001, Section 101.2, June 2004) outlined the make-up of a Local Planning Committee (LPC). It shall be made of 20 (twenty) members to include: the Superintendent (or designee), 4 parent members, 4 teacher members, 4 building administrators, the district facilities director (or designee), 1 central office staff member (certified or classified), 3 community leaders, 1 board member and a local building/zoning official. A maximum number of representatives from each school cannot exceed 1 (one). A minimum of 4 representatives must be members of an SBDM. The parent representatives shall be elected by the PTA/PTO in each school. The selection of the teachers and building administration representatives can be made by any process developed by the teaching/administrative staff. The Central Office staff member must be elected by those assigned to Central Office. The Community Leaders and Board member must be selected by the Board.
