**Recommendation/Motion:** Approve the withdrawal of the BG-1 Project Application for the radon remediation projects at Bryan Station High School, BTW-I (The Learning Center), Harrison Elementary, Leestown Middle School, LTMS, Mary Todd, Russell Cave, SCAPA and Sandersville in the amount of \$571,846.50 (Five Hundred Seventy-one Thousand, Eight Hundred Forty-six Dollars and Fifty Cents).

**Background/Rationale:** Based upon the unknown details of the project and the expectation that building modifications (requiring the involvement of an architect and engineer) would be necessary, a BG-1 Project Application for the emergency radon remediation at nine FCPS schools was presented to and approved by the Board in March 2016 and then submitted to KDE. Once the project was underway it became clear that modifications would be minor or non-existent. All work will be planned, reviewed and supervised by the FCPS Safety Supervisor and the consulting industrial hygienist and performed by certified radon remediation contractors. After discussion with the facility officials at KDE it has been determined that this remediation work falls into the category of "repair" work. Combined with the fact that only general fund money is being used to pay for the repair/remediation work, KDE agrees that the BG-1 is not necessary. With the Board's approval, we will request that the project application be withdrawn. The radon remediation will be conducted as scheduled with the work planned to be completed during the summer break. The previously submitted cost estimates and fund usage will remain the same.
