**SUBJECT: APPROVAL OF THE WORLDS FINEST CHOCOLATE FUNDRAISER

East Hardin Middle School's Related Arts Teachers are seeking permission from the Board to host a school wide fundraiser during the month of August & September to sell candy bars from World's Finest Chocolate Co. The proposed fundraiser will be used for the following reasons:

- a. P.E – The physical education department needs money to replace and purchase equipment (various balls (basket, baseball, kick, and playground), bases, bats, etc.).
- b. Art -The art department needs money to purchase clay and replenish supplies each 9 wks
- c. Music – The music department needs to purchase ocarinas and replace recorders, jacks and splitters, headphones and repair keyboards.




