The Board shall require the renting organization to assume all liability for injury to individuals by reason of the lease of District property and to indemnify and save harmless the Board from any loss or damage thereby. - To provide appropriate equipment for the use of District property. When gymnasiums are used, the organization agrees to permit on the gym floor only those persons wearing shoes that will not mar WS.
- To abide by the requirements of Board policies 05.3 and 05.31 (see attached). Disregard of the rules and regulations governing the use of the school buildings, equipment and facilities shall result in the refusal of the Board to grant the offending organization further use. WS
- To acknowledge that approval of this request does not signify District sponsorship, endorsement or approval of your organization or the activity. WS
