| 2 | 01.61 | Records Management | State - HB5 (2014 RS); 702 KAR 1:170 | Adds updated language regarding Information Security Breaches. POSSIBLE NEW LANGUAGE FOR CLARITY. |
| 3 | 03.11 | Certified - Hiring | Federal - ESSA | Removes language requiring teachers of core academic subjects to be "highly qualified" as defined by state and federal regulation. |
| 4 | 03.111 | Certified - Medical Examination | Federal - ADA & FMLA | Adds reference to ADA and FMLA with regard to medical exams for present personnel |
| 5 | 03.112 | Certified - Certification & Rec | Federal - ESSA | Deletes language requiring notification of parents of students in Title I schools being taught by teachers who are not "highly qualified" |
| 6 | 03.14 | Certified - Health & Safety | Federal - 40 CFR 763.92; 40 CFR 763.93 | Requires asbestos training for staff who work in buildings with asbestos. |
| 7 | 03.211 | Classified -Medical Examination | Federal - ADA & FMLA | Clarifies that requirements of ADA and FMLA must be followed when an employee is asked to provide evidence of fitness. |
| 8 | 03.24 | Classified - Health & Safety | Federal - 40 CFR 763.92; 40 CFR 763.93 | Requires asbestos training for staff who work in buildings with asbestos. |
| 9 | 03.5 | Paraprofessionals | Federal - ESSA | Deletes language requiring notification of parents of students in Title I schools that they may request information regarding the qualifications of |
| 10 | 04.0 | Fiscal Management | State - 702. KAR 3:320 | Updates language regarding the qualifications of district finance officers. |
| 11 | 05.11 | School Property | State - 302 KAR 29:020 and 29:060 | Adds language to require Integrated Pest Management program. |
| 12 | 08.1312 | Home/Hospital Instruction | State - Clarifying language; 704 KAR 3:303 | Provides clarifying language regarding information to be considers by an ARC committee when determining homebound services |
| 13 | 08.133 | Extended School Services | Federal - ESSA | Deletes language regarding Supplemental Education Services. |
| 14 | 08.3 | School Calendar | State - HB 80 (2016 RS) | Clarifies that if a district has no school school in the district has a polling place. |
| 15 | 09.11 | School Attendance Areas | Federal - ESSA | Deletes language regarding a requirement to offer students in a PLA school the opportunity to transfer. |

| 17 | 09.123 | Absences & Excuses | State -HB 87 & SB 256 (2016 RS) | Permits excused absences for students attending US Armed Forces basic training. |
| 18 | 09.1231 | Dismissal from School | State - Clarifying language - CHFS | Clarifies language to require a court order before a direction from CFHFS regarding who may pick up a child from school is followed. |
| 19 | 09.14 | Student Records | Federal -Clarifying language; ESSA | Clarifies language regarding parent access to student records. |
| 20 | 09.227 | Child Abuse | State - HB 111 (2016 RS | Requires display of statewide child abuse hotline in schools. |
| 21 | 09.313 | Eligibility (Athletics) | <i>Recommended by KSBA (not required by law)</i> | District may approve standards covering students "playing up" from middle to HS and recent matters per recent OAG opinion. |
| 22 | 09.36 | Field Trips & Excursions | State - Clarifying language; 702 KAR 7:125 | Clarifies that field trips must be instructional or co-curricular for students to be counted as present. |
| 23 | 09.422 | Bullying/Hazing | State - SB 229 (2016), amending KRS 158.148 | Changes definition of bullying. Note - revised Code of Conduct has been updated to incorporate this change. |
| 24 | 09.438 | Student Discipline Code | State - SB 229 (2016), amending KRS 158.148 | Adds language pertaining to bullying. |
| 25 | 02.4244 | School Hiring (SBDM) | State - HB 184 | Provides for alternative principal selection process. |
