This maintenance work will identify and repair issues such as bad cabling, traffic, etc. that cause network issues. As well as toning/testing all network lines, and providing proper labeling of all network ports. These quotes also include installing and reconfiguring networking equipment at both the high school and bus garage that have been identified as hazardous. Dear Ms. Fundora,

This is the quote you requested for the system wide "clean up" project. This is a "not to exceed" quote, meaning we anticipate the total cost of the project to be in the neighborhood of 50-75% of the quoted price. Due to the nature of the scope of work, an exact estimate is not possible. The quoted price you see on this document is the cost of a worst case scenario. Should we finish in less than 160 labor hours, you will be billed time and material for only the hours worked at a rate of \$68 per hour.

At every school in the district we will tone, test, and re-label every wire that is not properly labeled (thousands.) We will clean up all MDFs and IDFs by implementing proper wire management to include vertical and horizontal, two sided wire managers (dozens.) We will reuse your patch cables where possible but, we have included 500 three foot patch cables to correct the shortage of proper length patch cables. We will properly ground every rack in the district to help prevent further damage from lightning. We will properly enclose your fiber optics in rack mounted enclosures in order to protect your considerable investment in backbone cabling.
