The agreement period extends annually for a five-year period beginning September 1, 2016 and ending August 31, 2021. The Spencer County Public Schools reserve the right to terminate the agreement each anniversary pending written approval by both the bid awardee and the superintendent, or designee.

- 2. The successful bidder will be expected to deliver items to the site from which items were ordered. Deliveries are to be made during school hours only unless otherwise arranged by the school representative. No item is to be delivered without prior approval of the cafeteria manager or principal (or designee) of the school. Any advance delivery must be pre-approved by the principal, designee or cafeteria manager.
- 3. This bid will establish uniformity of procurement of cafeteria commodities for use in all of the Spencer County Public Schools; however, the bid does not supersede any current or future OVEC bid relating to state approved cafeteria beverages. While the Board of Education will approve the bid, individual schools will make the purchases. Payment for goods will be made following approval at the next regular meeting of the Spencer County Board of Education.
- Spencer County Public Schools personnel, prior to leaving any shipment or delivery, must sign all delivery invoices. The Spencer County Public Schools will not be held liable for any shipments left without signature.
- 5. All agreements over \$10,000/\$7,500, awarded by the School Food Authority (SFA), must include a provision to the effect that the SFA, the State Agency, USDA, the Comptroller General of the United States, or any of their duly authorized representatives shall have access to any books, documents, papers, and records of the contractor which are directly pertinent to that specific contract, for the purposes of making audit, examination, excerpts, and transcriptions.
- 6. The designated supplier(s) reciprocally agrees to provide total requirements as listed herein, thereby minimizing occurrences when a school may have to seek interim product sources. Failure to deliver 100% of the items on this list within 48 hours shall be considered a default without communicating to designated school representative.
- 7. Bid awardee is required to provide soft drink vending machines in locations specified by bidder. Vending machines must provide change and include an on/off timer feature. Vending Machine timers will be set in accordance with the Healthy Hunger Free Kids Act (HHFKA).
- 8. Vending machines shall arrive with lighting removed, disabled, or LED.
- 9. Deliveries must be guaranteed within 2 working days of ordering (if specified) and emergency service must be performed within 24 hours of reporting.
- 10. Competitive Food Sales KRS 158.854(3) prohibits sales of any item in competition with the breakfast and lunch programs from the time of the arrival of the first student in the morning until thirty minutes after the last lunch period.
- 11. Beverage Sales and Content. During the period of time beginning thirty (30) minutes after the last lunch period and until the end of the regular school day, a beverage offered for sale through a vending machine, school store, canteen, or fundraiser on school property shall:
 - (1) Be a:
- (a) Fluid unflavored or flavored milk shall be skim milk;
- (b) Plain or flavored, non-caloric, noncarbonated water;
- (c) 100% fruit or vegetable juice or any combination of both totaling 100%; or
- (d) Any other beverage that contains no more than (10) grams of sugar per serving, except this limit shall not apply to 100% fruit or vegetable juice or any combination of both equaling 100%;

and

- (2) (a) Except as provided in paragraph (b) of this subsection, not to exceed a volume size of (17) ounces, except for plain or flavored, non-caloric, noncarbonated water or
 - (b) For sales to middle school or high school students (6-12 grade) the volume size of a beverage shall not exceed (20) ounces.
- 12. All drinks are available after school hours in middle school and high school.
- 13. Energy type drinks of any kind will not be permitted to be sold on campus.

- 14. The contract shall comply with current school nutrition legislation.
- 13. Restrictions are not applicable to teacher work rooms or bus garage unless legislated.
- 14. Examples of drinks to be available: Waters (including flavors and/or vitamin), 100% Juices (all flavors), Tea (including diet), Athletic Drinks, Diet Soft Drinks (all flavors), Caffeine Free Diet Soft Drinks, Diet Drinks with artificial sweeteners, and Soft Drinks (all flavors)
- 15. Schools will determine their option of Self-Service or Full-Service.

Vending Machine Setup for Optimal Sales

Except for vending machines in the teacher workrooms, water, flavored water, and tea drinks, the vending machine timers shall be set to only allow sales 30 minutes after the last lunch period is served.

Carbonated soft drinks will be separate vending machines and timers shall be set to allow sales after the regular school day. Carbonated drinks shall not be sold during the regular school day.

Vending machines in the teacher workrooms can have combinations of all drink types.

Bid Instructions

- 1. Submit one copy of your completed bid on the form supplied in a properly addressed envelope clearly marked <u>BID Response for Soft Drinks</u>
- 2. Prices must be stated in units of quantity as specified and extended in total column for each item and/or lot. All bid prices must include transportation and delivery to the building as specified.
- 3. Bids, to receive consideration, must be received prior to time designated in this invitation, and none will be accepted thereafter. Faxed documents are acceptable for bid consideration with the understanding that the bid isn't sealed. (FAX 502-477-3259).
- 4. Bid form must be signed by an officer or member of the bidding firm who is authorized to legally bind the firm.
- 5. The Board of Education reserves the right to waive defects and informalities in proposals, to reject any or all proposals, or to accept any proposal as may be deemed to its interest and to award by item, combination of items, or lot.
- 6. All bids shall be effective for thirty (30) days from date of opening unless otherwise specified in special conditions of bidding, and no bid may be withdrawn prior to that time.
- 7. Manufacturer's catalog numbers, trade names, etc., where shown herein, are for descriptive purposes to guide the bidder in interpreting the standard of quality, design and performance desired, and shall not be construed to exclude proposals based on furnishing other types of materials or service. However, any substitutions or departure proposed by bidder must be clearly noted and described, otherwise it will be understood that bidder intends to supply items specifically mentioned in the bid invitation.
- 8. Specified samples may be furnished free of expense to Spencer County Public Schools. Right is reserved to mutilate or destroy any specified samples in the evaluation process. Unused samples will not be returned to except by specific request and at total bidders' expense.
