

AGREEMENT

This agreement made and entered to be effective the 1st day of May, 2016, by and between **THE METHODIST HOME OF KENTUCKY, INC**, hereinafter Methodist Home, and the **FISCAL COURT OF OHIO COUNTY**, by and through David Johnston, Judge Executive, hereinafter County;

WHEREAS, the Methodist Home maintains an emergency shelter facility in Owensboro, Kentucky, known as the Mary Kendall Campus Emergency Shelter, for the temporary placement of juveniles in lieu of detention; and

WHEREAS, the County is financially responsible for placement of juveniles by the district court in the event they are not committed to the Cabinet for Health and Family Services;

NOW, THEREFORE, for and in consideration of the county paying \$60.00 per day per child and the Methodist Home providing its facilities to the County, the parties agree to the following terms and conditions:

1. That the County will pay the Methodist Home upon receipt of billing statements reflecting the number of children in care for the County and the number of days in care.
2. That the Methodist Home will maintain its facility in compliance with all state regulations and provide for all the reasonable needs of the children while being cared for by the Mary Kendall Campus Emergency Shelter.
3. The County will be responsible for transportation of the child to and from the Mary Kendall Campus Emergency Shelter, and for payment of necessary medical and psychological services.
4. All children accepted and cared for at the Mary Kendall Campus Emergency Shelter will be maintained at the Shelter strictly pursuant to its intake criteria.


