WORKING BUDGET

BACKGROUND AND RATIONALE:

- In January, the District Board of Education must review the <u>Draft Budget</u>.
- In May, the District Board of Education must approve the Tentative Working Budget.
- Upon receipt of its certified assessment and maximum permissible tax rates from the Kentucky Department of Education, the District Board of Education has thirty (30) days within which to levy tax rates.
- The <u>Final Working Budget</u> is the fourth step in the budgeting process. Within 30 days of the adoption of the current school year's tax rates, or no later than September 30, the District Board of Education must approve the Final Working Budget.

The Final Working Budget reflects the discussion and action of the Board of Education. The Final Working Budget also reflects the new tax rates as adopted.

The Final Working Budget is presented for approval. It includes prior year's receipts and expenditures, the current proposed receipts and expenditures and the recapitulation of receipts and expenditures for the General Fund, Special Funds and Debt Service.
