**Recommendation/Motion:** Approve a revision to the BG-1 Project Application for a total of \$247,701 (Two Hundred Forty-seven Thousand, Seven Hundred One Dollars) for the renovation of the Tates Creek High School Shot Put and High Jump, subject to the approval of the Kentucky Department of Education, District Facilities Branch, per the provisions of 702 KAR 4:160.

**Background/Rationale:** The existing shot put and high jump areas were installed at TCHS more than ten years ago by FCPS to provide the bare minimal accommodation to suit these two track and field events. But due to the limitations of space and materials, these installations could not be used for KHSAA-sanctioned competitions. In order to comply with the KHSAA requirements and the rules of the sport, the existing area needs to be re-graded to suit these two athletic activities, with built-in storm water drainage and ADA-accessibility. Concrete pads will be provided to suit the shot put and high jump activities, and concrete walkways are provided for spectator viewing. The project will be funded through residuals from closed General Fund projects and General Fund and is subject to the approval of the Kentucky Department of Education. The revised BG-1 Project Application approving the bid was approved by the Board at its January 25, 2016 meeting. The proposed revisions to the BG-1 are indicated in the table below and are based on Change Order #1 to be considered and acted upon separately by Board at the September 26 meeting.
