Action/Discussion Item: RETROACTIVE APPROVAL (contract agreement): BLES 7th & 8th grade certified sponsors/teachers are requesting to attend the Jenny Wiley Theater's performance of the "Elf Jr." through the Jenny Wiley Theater. To attend this performance, the JWT is requiring an agreement to be signed. The agreement is attached.

Applicable Statutes or Regulation: Bd. Policies 05.3 & 05.3 AP.1; 05.31 AP.21; 05.33

<u>Issue:</u> To sign the agreement as outlined in the attached document.

Background: Jenny Wiley Theatre productions are traditionally high quality and allow students a chance to view a live performance with professional actresses and actors. Jenny Wiley Theater has also been very supportive of our school system in the past and has even partnered with our school on school productions.

Budget/Financial Issues: All ticket costs will be paid entirely through student fundraising.

Alternative: To not sign the agreement due to legal issues or non-negotiable standards.

Recommended Action: To sign the agreement, which will in turn reserve seating for our 7th/8th grade students at the Elf, Jr. Performance.

Rationale: This production will expose students to a live performance and will align with the demonstrators and characteristics outlined in our Arts & Humanities/Visual and Performing Arts Program Review. In addition to watching the live performance, teachers will follow up with appropriate in-class activities to further enrich the experience, such as writing, presentations and/or analyses.
