## **Bid Recommendations:**

### **Building Supplies Bid # 17-16-5-11**

Invitations were sent to 3 local vendors for building supplies. There were no responses returned for the bid opening on Thursday October 27<sup>th</sup>. We will rebid before the November 21, 2016 Board meeting.

### **Gasoline & Diesel Fuel Bid # 18-16-5-11**

Invitations were sent to Home Oil & Gas Company, Heritage Petroleum, LLC, Lynkins Energy Solutions, and Petroleum Traders. We received bids from everyone but Lynkins Energy Solutions. The bids were close between Home Oil & Gas Company and Petroleum Traders. Heritage Petroleum only bid on two of the options for fuel so they were eliminated. Home Oil & Gas was higher by 3 cents on the low sulfur diesel but were cheaper by 7 cents on unleaded 87 octane gasoline. Home Oil & Gas Company was also lower by 3 cents on E10 with 87 octane gas. The bids were evaluated according to the criteria in the bid invitation and Home Oil & Gas Company received the highest score on the evaluation. We are recommending the bid be awarded to Home Oil & Gas Company.

### **CNC Plasma Cutting Educational Ready Pak Bid # 21-16-5-10**

Invitations were sent to Modern Supply Company, Torchmate, and JD Squared. Bids were received from Modern Supply Company and Torchmate. Modern Supply Company was lower by \$6,500. We are recommending you award the bid to Modern Supply Company.

**Science Supplies Bid # 16-16-5-11**

Bids were received from 12 of the 16 vendors asked to bid. The discount rates varied in amounts but vendors offer many different materials. We are recommending that multiple vendors be awarded the bid so that schools can utilize products that best meet the needs of each school. The vendors are highlighted on the tabulation sheet that is attached.

**T-shirts, Sweat Pants/Shirts, & Polos Bid # 19-16-5-11**

Bid responses were sent to 23 vendors and we received bids from 15 of the 23. The discounts varied from 0 to 50%. Traditionally this bid has been awarded to multiple vendors so that each school can choose the product that is right for their needs. We are recommending multiple vendors, highlighted on the tabulation sheet enclosed, be awarded the bid.

**Teaching Supplies Bid # 15-16-5-11**

This bid has also traditionally been awarded to multiple vendors. Sixteen vendors responded with a bid ranging from 0 to 75% discount on multiple instructional items. We are recommending you award the bid to the highlighted vendors on the tabulation sheet enclosed. Schools can base their purchases on the company that best serves their needs.
