We only have 1 day left in the 4th month as I write this month's Report. I am excited to report that we have had a great month of teaching and learning and we continue to work to improve for the KIDS of Floyd County!

Our Plan of Excellence is in FULL SWING with every Floyd County School receiving a monitoring visit this by the end of this month. These visits are outstanding as we utilize our own leaders (administrators and teachers) visit a school and give feedback in the areas that we have goals and focus on for KIDS. This is one of the very best things we do to share best practices across our district as the people visiting and giving feedback are often the ones experiencing the most growth.

We continue to meet our goal of being a fiscally solvent and efficient district and we are proud of the board's leadership in this area. We have implemented an Early College Academy, moved to digital conversion for ALL KIDS 5-12 grades and given 5.5% raise to TEAM FLOYD in 6 years and we are still meeting our goal. We have the highest attendance in FC history each of the first three months in Floyd County and we are one day away from repeating this for the 4th month. We cannot say enough about TEAM FLOYD and our work on this issue. We are very passionate about this issue because KIDS must be in school to learn. Also, we want our KIDS to understand that a large part of success when they leave our school system is showing up every day and giving your very best. We have seen more use of our digital conversion this year than the past two years combined. The cultural change in how we teach is "starting" to become embedded. While we still have one more year to be fully implemented. We are growing weekly and will continue to work that FC kids have opportunities second to none in the country. The updated CDIP will be shared at the December Board meeting. Our CDIP guides our work for our KIDS and is developed to ensure we have a plan to continue to move our district forward and meet identified goals for our KIDS.
