## VII.B. Approval of 2017 Legislative Agenda

Judith Bradley and Dr. Randolph Wieck came forward to address the Board regarding this item. Judith Bradley also read a speech prepared by her son, Jack Bradley.

Dr. Hargens introduced this item as Jonathan Lowe, director of strategy, distributed the first option of the 2017 Legislative Agenda. Dr. Hargens stated that this option will give the Board an agenda to start with, and will not box them into anything. Mr. Lowe provided details of the draft. Each Board member had an opportunity to comment and ask questions.

Mr. Lowe explained that this option includes points that Board members suggested regarding Charter Schools. Dr. Hargens stated that the recommendation is to include the three points of legislation regarding Charter Schools that the Board came to consensus on and to include the following language: "should include, but not be limited to". This will allow the Board to be more extensive in the future.

Mr. Lowe distributed a second option that did not list specific points regarding Charter Schools, but did include the following language: "Note: At the January 10, 2017, Board Meeting, the Board will consider specific policy provisions for charter school legislation based on best practices to recommend to the General Assembly."

Chair Jones motioned to amend the 2017 Legislative Agenda to include the language in the second draft that was distributed by Mr. Lowe.
