Per request by the Floyd County Board of Education this is an academic and attendance report on our student athletes participating in our district.

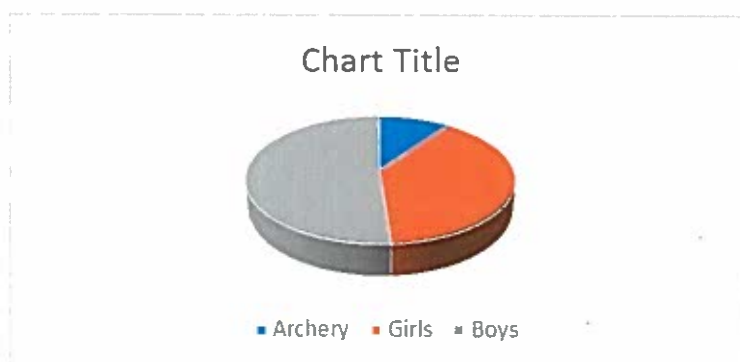
Below is the breakdown of our winter elementary, middle and high school athletic teams.

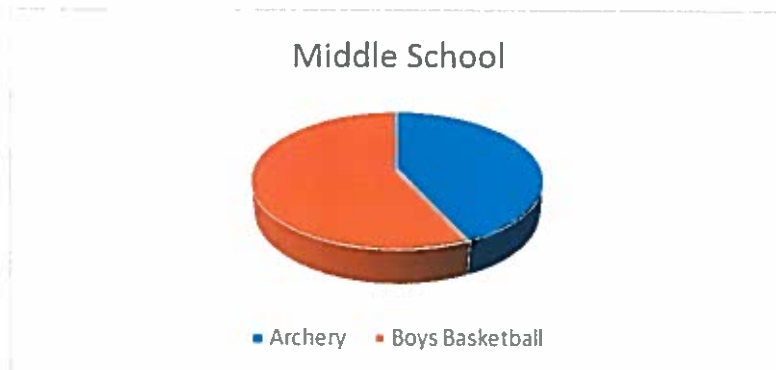
