Teacher Shortage vs. Distribution, Short-term and Long-term

At the February 13, 2017, Board meeting, a vision for the Board to consider about possible short and long-term solutions to the teacher distribution challenge currently facing Kentucky school districts was outlined. In my statement I explained that based on data concerning the number of teachers graduating from our educator preparation programs, a sufficient number of certified teachers exisits to fill open positions statewide. The problem occurs because certified teachers are not choosing to seek positions where the job vacancies exist. Therefore, in a number of districts, there is a shortage.

For a short-term solution, I have asked staff to rewrite 16 KAR 5:030, the Proficiency evaluation regulation, so that an Education Preparation Provider (EPP), with an approved program in the area being sought by a certified teacher in Kentucky, could:

- 1. conduct a proficiency evaluation;
- 2. determine the areas of deficiencies;
- 3. create an teacher proficiency learning plan (TPLP);
- 4. recommend to the EPSB that the individual is eligible for a provisional certificate;
- 5. allow the person to start teaching in the area being sought.

Similar to the Option 6 program, the teacher would be required to have an offer of employment in the area being sought.



For example, a district may need a high school mathematics teacher, but only has candidates who currently hold a middle school mathematics certificate for grades 5-9. The proficiency evaluation may result in the candidate being found deficient in necessary content courses and also passing the appropriate content exam. While the candidate is completing the TPLP, he or she would have a provisional certificate allowing him or her to teach immediately.

For the long-term solution, I encourage each district to start a "grow your own" program that was first discussed in the March 2016 EPSB Update Memo. The Kentucky Department of Education is developing a career pathway for teaching that has tremendous potential. I have also asked EPSB staff to review some of our practices on clinical hours and student teaching in schools of origin. Coupling a "grow your own" program with a career pathway, and then allowing the candidates to "come home" for clinical hours should assist districts in retaining their "homegrown" talent.

In the next few weeks, the Kentucky Center for Education and Workforce Statistics (KCEWS) will release a supply-and-demand study for the teaching profession in Kentucky. Knowing the projected vacancies in your district in the coming years should help you develop plans with your regional EPPs so that you are able to fill positions, quickly and deliberately, with highly effective teachers.

Spring LEAD Report Due; HQ Teacher Report No Longer Required

Districts should have signed-off and finalized their spring LEAD reports by Tuesday, February 28, 2017. This is the first year that the Highly Qualified Teacher Report has not been required following the spring LEAD report. This reporting requirement was discontinued following the 2015-2016 school year and is no longer mandated under the Every Student Succeeds Act (ESSA).

Nominations Sought for Reading and Content Area Program Review Committees

The Division of Educator Preparation is seeking nominations for representatives from local school districts, cooperatives, and colleges and universities to serve on its Content Area Program Review Committees as well as the Reading Committee.

The Content Area Program Review Committees provide content area expertise. They are charged with evaluating educator preparation program review documents and reviewing program content to ensure adequacy of preparation and alignment to Specialty Professional Area (SPA), Kentucky Academic Standards, Council for the Accreditation of Educator Preparation (CAEP), InTASC, and Kentucky Teacher Standards. The review is conducted electronically and there are no meetings to attend.

These committees submit written comments to the EPSB staff and the Reading Committee for use in the program approval process. These committees do not make any determination or decision regarding the approval or denial of a program. Nominations are needed in the following content areas:

The Reading Committee is charged with conducting a preliminary review of pre-accreditation materials and programs from educator preparation institutions for conformity with the corresponding standards and state guidelines. The committee meets in the spring and fall semesters of each year. This committee is Board appointed and assists staff with recommendations regarding program approvals.

The Content Area Program Review Committees and the Reading Committee play an important role not only for EPSB, but in the self-governance and accountability of our statewide work. Title II: The Institutional and Program Report Card (IPRC) Reporting System is Now Open

IPRCs are due on April 30, 2017. EPSB will provide each Educator Preparation Program (EPP) data compiled from the Admission and Exit (A&E) system and Certification records to be used in completing sections I.c: Enrollment; I.e: Teachers Prepared by Subject Area; and I.f: Program Completers. The data will be provided the first week of March. EPPs confirmed the 2015-16 academic year A&E data in September 2016; however, any errors should be corrected at this time.

Westat's Title II Service Center has scheduled two webinar trainings targeted towards teacher preparation programs. All Kentucky teacher preparation programs are encouraged to participate.

 brief review of Title II reporting requirements, highlight and address FAQs, demo key sections of
 the IPRC based on FAQs to date, review tips for successful reporting, and offer a Q&A session.
