Following are status reports on the following projects:

# BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

The entry road lime stabilization, filter fabric and stone base have all been installed and there is currently access to the building pad. The construction trailers have all been placed and concrete footings and foundations are underway. The contractor is starting in the most complex portion of the site, which is the Gymnasium and mechanical areas, then will work around to the two story sections and then follow with the front entry. Progress appears to be on schedule for occupancy as anticipated – there is a detailed construction schedule which outlines all of the progress that will occur between now and Summer 2018. We will continue to monitor the project on a weekly basis.
