## Addendum for RFP E-Rate 470 2017

Invitations were sent to Aruba, Dell, Extreme Networks, and Hewlett Packard for this RFP. We received e-mail notification from Felicia Ragland with Aruba that this company would "no-bid" this RFP if E-Rate funds are being used. We did receive a bid from Extreme Networks for a grand total of \$181,489.80 for equipment and installation charges. The other companies did not return a bid.
