3.1 Personnel	The Every Student Succeeds Act prohibits employers from providing anything more than administrative and personnel files for school employees, contractors, or agents that they know or have probable cause to believe have engaged in sexual misconduct with a minor.	None anticipated.
3.1211 Salary Deductions	Updated language to conform to SB 6, which states that deductions for membership dues of an employee organization, association, or union can only be made on the express consent of the employee. Consent may be revoked at any time with written notice to employer.	None anticipated.
3.13253 Domestic/Dating Violence Reporting and Education	New policy to conform to HB 309, which requires reporting acts of domestic violence and abuse or dating violence and abuse to law enforcement on the request of the victim. School personnel must report when he/she has a belief that the death of a victim is related to domestic/dating violence or abuse. School personnel must provide educational materials if they believe a victim has experience domestic/dating violence or abuse.	None anticipated.
3.14 Health and Safety	Update language to conform with 40 C.F.R. 763.92, which requires custodial or maintenance staff who may work in a building with asbestos to have a minimum of two (2) hours of asbestos awareness training. Staff who will be involved in activities that involve a disturbance of asbestos-containing materials must receive an additional fourteen (14) hours of training.	Costs associated with training maintenance and custodial staff.
4.92 Uniform Guidance	New policy to adhere to 2 C.F.R. 200.430, which requires districts to follow uniform grant guidance for tracking personnel expenses paid for by federal funds. Auditors of federal funds may ask for a policy stating the district's adherence.	None anticipated.

7.12 Vending Machines	Updates language to comply with 702 KAR 6:090, which defers to federal regulations for state nutritional requirements.	None anticipated.
8.1 Curriculum	Updates language to conform to revisions made to 705 KAR 4:231, which regards program standards for Career and Technical Education. The regulation went into effect in January.	None anticipated.
8.113 Program Completion	Updates language to conform to SB 159, which requires students to pass a civics test with questions taken from the U.S. Citizenship Exam. Updates language to conform to HB 522, which allows state agency children who are at least seventeen (17) to seek a High School Equivalency Diploma.	None anticipated.
8.1131 Work-Based Learning	Updates language to conform to revisions made to 705 KAR 4:231, which regards program standards for Career and Technical Education. The regulation went into effect in January.	None anticipated.
8.14 Counseling Services	Clarifies that information reported to counselors will be kept confidential to the extent allowable by law. Reporting statutes may require counselors to speak with relevant authorities.	None anticipated.
8.2 Instruction	Updates language to conform to revisions made to 705 KAR 4:231, which regards program standards for Career and Technical Education. The regulation went into effect in January.	None anticipated.
8.221 Grading	Updates language to conform to SB 17, which requires assessment of student work to be free from religious or political discrimination.	None anticipated.
8.3 School Calendar	Updates language to allow districts to be open on an election day if no school in the district is used as a polling place, subject to the requirement that schools shall be closed on a Presidential Election Day.	None anticipated.
9.1231 Student Release	Updates language to conform with HB 33, which details the Cabinet for Health and Family Services (CHFS) notification requirements. The language clarifies that a school follows the direction of the CHFS as to who may pick up a child from school only after a court has issued an order committing the child to the CHFS. The language clarifies that a student's parent is not to be notified if a court order provides to the contrary.	None anticipated.

9.12311 Release of Students to Divorced, Separated, or Single Parents	Clarifies that release of a student and release of records are handled separately. Release of records is covered under access to student records under the Family Educational Rights and Privacy Act (FERPA).	None anticipated.
9.13 Equal Educational Opportunities	Updates language to conform to SB 17, which allows students to express religious or political views.	None anticipated.
9.14 Student Records	Clarifies that information regarding a student’s living situation is not considered “directory information” for the purposes of FERPA. The language clarifies that legal separation or divorce alone does not terminate a parent’s right to access their student’s records. The language clarifies that disclosure of Personally Identifiable Information (PII) to school officials with a “legitimate educational interest” may include medical staff and/or law enforcement if employed by the district.	None anticipated.
9.2211 Employee Reports of Criminal Activity	Updates language to conform to HB 309, which requires reporting acts of domestic violence or abuse and dating violence or abuse upon the request of the victim. School personnel must report when he/she has a belief that the death of a victim is related to domestic/dating violence or abuse. Updates to require school personnel to report when they know or have reasonable cause to believe a student is the victim of human trafficking.	None anticipated.
9.227 Child Abuse	Updates language to conform to HB 33, which requires that when the CHFS is awarded custody of a child, it must notify a school administrator of who may remove the child from school grounds and the school administrator must document the notification. Updates language to conform to HB 524, which requires schools to display the National Human Trafficking Reporting Hotline number. Updates language to conform to HB 253, which requires a school to provide the CHFS access to a child subject to an investigation without parental consent. Updates language to conform to HB 111, which requires schools to display the Child Abuse Hotline number for the CHFS. Updates to require school personnel to report when they know or have reasonable cause to believe a student is the victim of human trafficking.	Cost of signage.

9.32 Student Organizations and Student Speakers	Updates language to conform to SB 17, which allows students to express religious or political views when speaking at official events.	None anticipated.
9.36 School-Related Student Trips	Clarifies that for students to be counted present, school-related trips taken during the school day must be instructional in nature. The language conforms to 702 KAR 7:125.	None anticipated.
9.422 Bullying/Hazing	Updates language to conform to SB 228, which includes a new definition of “bullying.”	Cost of printing codes of conduct.
9.425 Assault and Threats of Violence	Updates language to conform to HB 309, which requires reporting acts of domestic violence and abuse or dating violence and abuse to law enforcement on the request of the victim. School personnel must report when he/she has a belief that the death of a victim is related to domestic/dating violence or abuse. School personnel must provide educational materials if they believe a victim has experience domestic/dating violence or abuse.	None anticipated.
9.4361 Police Officers in the School	Updates language to conform to HB 253, which requires a school to provide the CHFS access to a child subject to an investigation without parental consent.	None anticipated.
