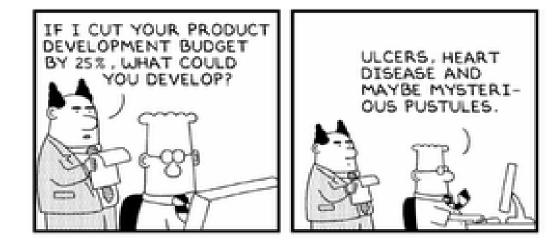

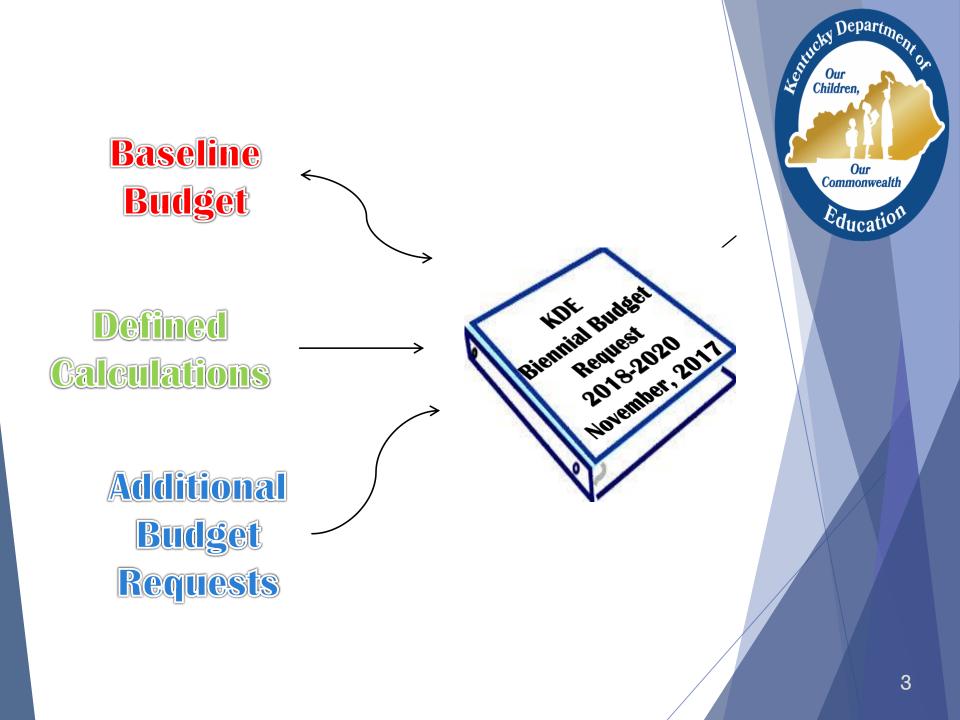

P-12 Baseline Budget

- The purpose of a Baseline Budget Request is to identify and record expenditures by both <u>object</u> <u>classification</u> and <u>fund source</u>.
- Baseline Budget Requests support, to the extent possible, a continuation of currently conducted activities, services delivered, and/or programs that are in effect in the current year FY.
- The Baseline Budget Request reflects the same budgeted amounts (for all funds) to continue to support programs and activities at the current level of service to the extent possible.

- Other Personnel Professional Contract Costs
- Operating Supplies, Travel, Rent, Utilities, etc.
- Grants Typically Funds Sent to Districts by Formula or Competitive means.
