

History/Background: Reward trip for football players. This trip also enables student athletes to have the opportunity to experience the Great Smoky Mountains.


Fiscal Budgetary Impact: Trip will be paid for by Football Boosters.

CANCELLATION If coach is cancelled 30 days prior to departure date, no cancellation fee will be assessed
