IV. Technology Fees

Discussion:

Mr. Brian Bailey presented information to the Board to consider a technology fee for North and South Middle Schools beginning the 2017-2018 school year to insure a device and provide a fund to purchase replacement parts for devices. Mr. Bailey stated that, according to our Responsible Use Policy, staff and students are responsible for a device that is lost, stolen or damaged beyond repair. Mr. Wes Smith asked about students on free or reduced lunch. Mr. Bailey stated that they would work with the families to put them on a payment plan. Dr. Sally Sugg stated that it pains her to charge needy families. Dr. Sugg is in support with the intention that some families can be placed on a payment plan, find some donors in the community or use Family Resource Centers. Mr. Mike Waller and Mr. Wes Smith are in support of the fee. Mrs. Lisa Baird is in support of the fee, but would like to see a reduction in the annual textbook fee at the High School making the combined fee for technology and textbooks of \$50. Mr. Bailey stated that the fee would only be levied on students with a 1:1 device and that next year this would only include middle school students. Mrs. Elizabeth Bird stated that, if we are requiring students to use the device in the classroom, then that would be under the same regulations and guidelines as textbooks, workbooks, etc... Mrs. Marganna Stanley confirmed with the Board that \$25 is a reasonable amount for the fee. Mrs. Stanley also stated that the textbook fee is more of an instructional resource fee. Dr. Sally Sugg agreed that instructional resources is the way that we need to move. Mrs. Tracey Williams reminded the Board that no elementary child has to pay for lunch, which makes it easier to swallow this fee.
