**Action/Discussion Item:** Approve the Principal of each school in the Floyd County Public School district as the chairperson of School-Based Admission and Release Committee (SBARC) meetings and an alternate administrator from each school to serve as the Principal's designee to chair a SBARC meeting.

**Applicable Statutes or Regulations:** Floyd County Special Education Procedures: Individual Education Programs-ARC membership.

**Background and major Policy Implications:** It is recommended that Principals chair the majority of, if not all SBARC meetings. Designees should chair meetings only when necessary. A chairperson of a SBARC meeting must be a representative of Floyd County Schools who is qualified to provide, or supervise the provision of, specially designed instruction to meet the unique needs of children with disabilities, and one who is knowledgeable about the general education curriculum and the availability of the resources of the Floyd County Schools. The Superintendent, in consultation with the Director of District Wide Services, will recommend to the Board for approval a list of Floyd County representatives by job or position title. The Superintendent, or designee, may designate which specific staff member on that approved list will serve as the Floyd County representative for any SBARC meeting.

**Alternatives:** None proposed.

**Recommended Action:** The Principal of each school should serve as the chairperson of School-Based Admission and Releases Committee (SBARC) meetings or name an alternate administrator from the school to serve as the Principal's designee.
