It is not the intention of the parties that the Company assume responsibility for any loss occasioned by malfeasance or misfeasance in the performance of the services under this contract or for any loss or damage sustained through burglary, theft, robbery, fire or other cause or any liability on the part of the Company by virtue of this agreement or because of the relation hereby established.
- 6. This agreement is subject to acceptance by the Company.
- 7. If this contract is broken by the Subscriber, no monies will be returned for the remaining time the contract is in effect. If broken by the Company, the balance of the unused monies will be returned to the Subscriber.
- 8. The Subscriber hereby agrees to indemnify the Company and hold it harmless from and against any claims or demands which may be asserted against the Company, including reasonable attorney fees necessary to defend such claims or demands, arising out of the maintenance and/or installation of the alarm system or any of its components.
- 9. If any agency or bureau having jurisdiction, or subscriber by his or its own act shall require or make necessary any changes in the system as originally installed. Subscriber agrees on demand, to pay for the cost of such charges. Any increased charged made to Subscriber by the telephone company for such things as leased lines used in connection with the services rendered under agreement, shall be borne by Subscriber.
