

Prestonsburg High School 2014-2015 / 2015-2016 School Years









Heating degree day (HDD) is measurement designed to reflect the demand for energy needed to heat a home or Business. It is derived from measurements of outside air Temperature. The heating requirements for a given structure at a specific location are considered to directly proportional to the number of HDD at that location. A similar measurement, cooling degree day (CDD), reflects the amount of energy used to cool a home Or business.
