Rowan Co Multipurpose Athletic Complex

Mr. Mays:

In accordance with Project Specification 007300, we present the following time extension request based on inclement weather days accumulated in May 2017. Specifically, it has rained 20 of the 31 calendar days in May and caused major delays in performing the critical path activities for this project.

Based on the normal weather occurrence for rainfall events > 0.1 inches as reported by NOAA at the Farmers, Kentucky location (see attached), the actual rain events were 20 days compared to 12.8 normal days. Based on this criteria, we request 7 calendar days extension to the contract time. In addition, it has rained a total of 7.69 inches compared to a normal total of 4.86 inches (2.83" more than normal and spread out over the entire month). Out of possible 27 working days in May (Monday – Saturday), we have been able to work only 11 days due to wet site conditions for a delta of 16 missed work days due to rain and wet site conditions. Even portions of these work days have reduced due to preparing the site for rain before we could leave the site. The site soils for this project are very sensitive to moisture compared to other projects sites in central-eastern Kentucky. Therefore, based on the actual conditions for the month of May, we request a total time extension of 12 calendar days to the current contract completion date.
