Action/Discussion Item:

Education Professional Standards Board (EPSB) Administrative Regulation: 16 KAR 1:015, Standards for Certified Teacher Leader

Rationale:

Review and approval of this regulation by the Kentucky Board of Education (KBE) is required pursuant to Executive Order 2017-364 dated June 16, 2017. KRS 161.020(1) states, "No person shall be eligible to hold the position of superintendent, principal, teacher, supervisor, director of pupil personnel, or other public school position for which certificates may be issued, or receive salary for services rendered in the position, unless he or she holds a certificate of legal qualifications for the position, issued by the Education Professional Standards Board (EPSB)." Furthermore, KRS 161.028(1)(a) states that the EPSB is to "Establish standards and requirements for obtaining and maintaining a teaching certificate;".

During the October 2016 meeting, the EPSB accepted the recommendations from the Teacher Leader Master's Review Committee. The committee recommended that the Teacher Leader programs reflect the Teacher Leader Model Standards, which align with The Interstate Teacher Assessment and Support Consortium (InTASC) Standards. These standards identify the knowledge, skills, and competencies that teachers need in order to assume leadership roles in their schools, districts, and the profession.

During the April 2017 meeting, the EPSB received information as to the establishment of 16 KAR 1:015 to reflect the recommendations accepted at the October 2016 meeting.

Action Question:

Should the Kentucky Board of Education approve the establishment of 16 KAR 1:015?

Applicable Statute or Regulation:

KRS 161.020, 161.028, 161.030

History/Background:

Existing Policy: Teacher Leader Standards for Kentucky have not been previously established.

Summary: See rationale above.

Budget Impact: There are no additional costs or revenue to the EPSB to administer this regulation.
