II.B.1. Energy Report

Mr. Watts reviewed the most recent energy savings report from Trane which shows that our energy project has saved approximately \$270,000 in energy costs this year. The bond payment for the project was approximately \$240,000; showing an overall savings to the general fund for the current fiscal year. Review of the savings will take place on a quarterly basis and further energy savings practices will be implemented to increase the savings. Lighting projects are being studied to see if savings can be realized by replacing old lighting, with additional funding through AEP rebates to help pay for the projects. A project for the ATC will be proposed that will

greatly improve the lighting at the ATC, and will be reimbursed by AEP rebates at 40 to 50%.

II.B.2. Health/Preschool Report

Wayne Sizemore shared with the Board the school year health visits reported for the entire district. Overall, there were over 17,000 health visits documented in Infinite Campus, with less than 3% resulting in students being sent home. The nurses provide a worthwhile service to our students and make a tremendous impact on attendance for our kids, allowing them to remain in school, when possible.
