

2015-16 GENERAL FUND EXPENSE BUDGET versus ACTUAL Finance Advisory Committee August 10, 2017

Objective

- To explain the impact of projected savings, carryover, and carry forward.
- To explain how JCPS forecasts Working Budget expenses in order to match recurrent revenue with recurrent expenses.

Basic Truths

- Neither the Revised Expense Budget nor the Working Budget in MUNIS represent what we project to spend in a 12-month period.
- We do match 12 months of recurrent receipts to 12 months of projected expenses in our <u>financial</u> <u>planning</u>.
- We are transparent in our demonstration of the budget regarding the impact of savings, carryover and carryforward.

NOTE: reimbursement from Early Childhood for transportation expenses is possible but not guaranteed

CARRYOVER

- "Carryover" refers to the unused balances in flexible accounts that are provided back to the schools and depts. in the subsequent year.
- SCHOOLS: ranged from \$6.7 million to over \$9.5 million over the last six years.
- HIGH SCHOOL TEXTBOOKS: \$1.1 million in FY 2016-17.
- AFIF: About \$1.2 million in FY 2016-17

CARRY FORWARD

- "Carryforward" reflects year-end encumbrances. These are legal obligations covered by a specific budget for which payment had not been issued by year's end.
- \$16.5 million allocated in the 2016-17 Working Budget.
