Food Service Agreement

School Year 07/01/2017-06/30/2018

THIS AGREEMENT is made and entered into by and between Floyd County Board of Education operating as Adams Middle School and Mountain Comprehensive Care Center.

<u>Mountain Comprehensive Care Center</u> representative will arrange for daily pickup and distribution of meals to adult participants of <u>Prestonsburg Therapeutic Rehabilitation Program.</u>

<u>Mountain Comprehensive Care Center</u> agrees to pay the cost of each meal at a rate of <u>\$3.50</u> per lunch.

The Floyd County Board of Education operating as Adams Middle School representative shall provide the Mountain Comprehensive Care Center representative with a signed ticket at each meal pickup specifying the quantity of meals that is provided. Floyd County Board of Education operating as Adams Middle School shall submit an itemized invoice to Mountain Comprehensive Care Center which specifies the quantity of meals provided during the preceding month.

The <u>Floyd County Board of Education operating as Adams Middle School</u> will provide meals Monday thru Friday, during operation, unless cancelled by <u>Mountain</u> <u>Comprehensive Care Center</u> no less than 24 hours before the day in which meals will not be needed.

The <u>Prestonsburg TRP</u> representative will notify the school each morning of the number of meals needed for that day by <u>10:00 a.m.</u> The <u>Prestonsburg TRP</u> representative reserves the right to increase or decrease the number of meals ordered on a <u>2 hour</u> notice or less if mutually agreed upon between the parties of this agreement.

The <u>Floyd County Board of Education operating of Adams Middle School</u> agrees to package and provide meals in containers that meet local health standards and assures that it has state or local health certification at the preparation facility and assures that health and sanitation requirements will be met at all times.

This agreement may be terminated by either party upon 30 days written notification.
