# III. Establish 2017-2018 Property and Motor Vehicle Tax Rate

## Discussion:

Mr. Mike Waller stated that he is in favor of the 4% increase. He stated that there is minimum SEEK funding and the 4% tax increase was put on legislation as part of the means to fund education to do what is necessary to maintain a high level of education, which costs more each year. Mr. Waller stated that he appreciates the comments made at the public tax hearing, however, the education of this community rests upon the Board and if you look at surrounding counties, our tax rate is lower by a significant amount. Mr. Waller stated that it's about teachers and the folks that are bringing the education programs. The Board has been lacking in approving salary levels. Dr. Sally Sugg stated that the State has not followed through to fund the schools at the level that they have promised. It is becoming more incumbent on local boards to fund education. Dr. Sugg said that even though she is for the 4% increase, she really hopes that everyone will talk with their legislators about fully funding education. Dr. Sugg appreciates the comments

that the guests made during the hearing, however, we are all in the same boat. Dr. Sugg stated that the hard working people need a break and some of the hardest working people are our staff at the schools. Many could go to private industry and receive a much, much higher salary than we can afford to pay them such as our cooks, custodians, bus drivers, substitute teachers. For that reason, Dr. Sugg is for raising taxes in equalizing some of those salaries that are the lowest in our district. Mrs. Lisa Baird agreed with Dr. Sugg and noted that there are many neighboring counties that are so close in geography to us, that we stand a real chance of losing some valuable and highly educated educators to neighboring counties who can pay more than we can. Mrs. Baird said that we should all go back to our legislators and ask the State to come back and fund education instead of our local taxes. Mr. Wes Smith had no comment as his thoughts have already been said. Mrs. Tracey Williams reiterated that teachers have not had a raise in several years.
