## **Consent Agenda Item (Action Item):**

Request approval for interested 9<sup>th</sup> - 12<sup>th</sup> graders identified in the Gifted & Talented Program from Betsy Layne, Prestonsburg, and Floyd Central High Schools to participate in a study tour of New York City, Boston, and Niagara Falls. The tour will depart Monday, July 30 and return Friday, August 3, 2018.

## **Applicable Statute or Regulation:**

KAR 704 3:285 Section 6, Board Policy 09.36

## Fiscal/Budgetary Impact:

The NYC, Boston, with Niagara Falls study tour will be funded through parent contribution combined with \$2,500 funding to reserve charter from the Gifted & Talented budget. The tour is scheduled for Monday morning, July 30<sup>th</sup> through August 3, 2018. Therefore, students will not miss instructional days. The GT coordinator, GT instructor, and guidance counselor will chaperone the tour. There will be no cost for substitute teachers during the tour.

#### History/Background:

Within the last thirteen school years, gifted and talented  $9^{th}-12^{th}$  graders from Floyd County high schools have been given the opportunity to tour Washington, DC, New York City, Chicago, Orlando, the Biltmore Estate in Asheville North Carolina, and Nashville Tennessee. These tours have been some of the best "real world" educational experiences I have ever participated in with high school students. For some students, these tours have been their first time to travel to major metropolitan cities. The GT students participating in this study tour will be given the opportunity to experience the following:

- Times Square
- Broadway theatre Show
- "Cheers" Restaurant
- Boston City Tour
- Tea Party Ship Tour
- Boston Harbor Tour
- JFK Library Tour
- Albany University
- Niagara Falls & Ranger Program
- Maid of the Mist Tour
- Culinary Institute New York

This educational enrichment experience will provide opportunities to address the interests, needs, and abilities of all participating gifted and talented students in each of the areas of identification. The tour will also assist Floyd County Schools in meeting the requirement of Travel Study Option toward fulfilling the system's Gifted Student Service Plans (GSSP) for the Kentucky Department of Education.

These destinations were selected because of their immense educational value. Bluegrass Tours from Lexington Kentucky will be used to coordinate tickets, meals, hotel accommodations, and all transportation. Bluegrass Tours holds a \$5,000,000 liability policy (see attached policy).

## **Recommended Action:**

The GT students, their parents, and GT program personnel recommend that the Floyd County Board of Education approve the request for those gifted & talented 9<sup>th</sup> – 11<sup>th</sup> grade students interested in participating in the New York City, Boston, Niagara Falls study tour on July 30 – August 3, 2018 be allowed to do so pending compliance with all policies.
