**Call to Order – Jerry Wyman, President**

President Wyman called the July 15, 2017 meeting of the Board of Control to order.

**Review Schedule for Meeting and Solicit Necessary Additional Information (President Jerry Wyman)**

The Board President and staff will review the planned itinerary for the meeting and planned proceedings.

**Confirm Replacement of Retired Board of Control Member Mike Deaton**

Per the Constitution, the Board must replace retired Board of Control member Mike Deaton. Mr. Deaton retired from education as of July 1, 2017. Due to the fact that the retirement occurred within Mr. Deaton's last year of his term in office, the Board shall replace him. Mr. Deaton has suggested his replacement, Superintendent Kirby Smith, assume his position for the remainder of his term and Mr. Smith had indicated he would accept the position.

**The Board then Recessed into Work Session (Chaired by President-Elect Donna Bumps)**

During the work session, the Board discussed the various items on the work session agenda. Those being considered with no action taken were:

- **Event Ticket and Income Reports (TN, TR, FP, BA)**-The Commissioner and staff reported ticket revenue related to KHSAA events.
- **Initial Discussion, Trophy Contract for Member Schools**-Awards have long been standardized and contracted for district, region and state. Purchasing statewide has allowed for school savings as well as standardization. The current contract expires at the end of 2017-2018.  
This initial discussion centers on 1) desires to renew or not to renew with current vendor, 2) possible changes to the actual items presented at the district and region level if desired to lessen costs and 3) any potential changes at the state level.  
An alternative at the district and region level would be to shift those awards to plaques rather than trophies. This would likely lessen the cost to the schools and perhaps lessen shipping costs. However, during any transition, the aesthetic differences would be noticeable to the schools that receive multiple awards through the years. Staff will discuss at regional and Annual Meeting and report back to the Board.  
No action was taken, however the item will remain on future Board agendas.
- As a separate item, a discussion should be held as to the awards presented in track and field as this cost continues to be a burden to the membership and was referred to the Advisory Committee.
- **Status Report, Current Year Football Rules and Officiating Changes**-Commissioner Tackett reviewed information relative to the anticipated changes in playing rules, officiating mechanics including fees, coverages and visible play clocks.
- **Review Fastpitch Softball and Baseball Tournament Formats, next steps for future discussion**-The Commissioner led a discussion on the formats of baseball and softball state tournaments, and solicited thoughts on next steps from the Board members including any data desired.  
No action was taken, however the item will remain on future Board agendas.
- **Review Information, 2017-18 NFHS Basketball Rules Change, 28 foot coaching box**-The Commissioner provided information relative to the changes in the NFHS Basketball playing rules for the sideline coaching box. The KHSAA will utilize the 28 foot provisions.
- **Initial Discussions, Fastpitch Softball Pitch Count/Inning Limit, Mandatory Rest Possibilities**-The Commissioner and Assistant Commissioner Bilberry reviewed data at the request of specific members, and facilitated a discussion on next steps toward consideration of a pitching restriction in fastpitch softball.  
No action was taken, however the item will remain on future Board agendas.
- **Initial Discussions and Timeline Development, Football Reclassification and Realignment**-The Commissioner asked for additional input and provided a historical perspective to the Board as consideration to begin the process of reclassifying football and redistricting within those classes.  
No action was proposed or taken, however the item will remain on future Board agendas.
- **Initial Discussion and Timeline Development, Scheduling of 2021 Basketball Tournaments (And Years Beyond)**-The Commissioner solicited any data points needed for the Board to act in September on the possibility of adjusting the corresponding date calendar for basketball. Such would need to be finalized in September 2017 so that state playing facilities can be contacted, and potentially contracted, for 2021 and beyond.  
No action was taken, however the item will remain on future Board agendas.

- **Initial Discussion and Timeline Development, Realignment of Tennis to Match Basketball Regions**-This item was requested by members of the Board of Control for data to be presented regarding the tennis alignment, which is the only 16-region alignment that does not use the basketball boundaries as its framework.  
No action was proposed or taken, however the item will remain on future Board agendas.

President-Elect Donna Bumps concluded the Work Session to return to Full Board Meeting.

### **Consider Revision of Percentage of Ratings Assigned to Assigning Secretaries in BA, BK, FH, FB, FP, SO, VB and WR**

The Commissioner asked the Board to consider a revision of the Board policy recommendation regarding percentage of rating value assigned to assigners as part of required evaluation.

Currently, that recommended percentage (which sets the minimum for local policy boards) is twenty percent. With the limited participation by coaches in most regions, assigning twenty percent to the local assigner while assigning eighty percent to school representatives that may not participate, may not lead to the selection of the best officials for servicing postseason games.

Since the assigners are accountable to both the KHSAA staff and the regional policy boards a higher percentage to the assigners would likely lead to officials feeling a greater comfort level in enforcing sportsmanship objectives for the association within the playing rules.

The Commissioner and Staff recommended that the current twenty percent minimum be revised to fifty percent. Regional policy boards can increase that percentage but may not set a value lower than fifty percent.

### **Confirm dates and sites, 2017 State Field Hockey Tournament**

Commissioner Tackett and Assistant Commissioner Barren have extensively reviewed options for the State Field Hockey Tournament. Working around the schedule and other restrictions at Bellarmine University has proven difficult the last few years for both the KHSAA and Bellarmine.

Assumption High School is a good local school hosting option given their location and facility, and hosted the quarterfinals in 2016. Assumption, however, is not interested in hosting the entire event due to commitments to other events.

KHSAA staff sought an opportunity with Christian Academy Louisville, a school with a physical plant that could easily manage the event and conducted site visits and discussions with the school.

### **Consider Adoption of Requirement, Face Protection for Pitcher, First Baseman, Third Baseman, Fastpitch Softball**

Following the rejection of both KHSAA proposals to amend the NFHS playing rules, the Commissioner brought the recommendation that for all levels of play among KHSAA members, face protection be required for fastpitch softball players playing the positions of first base, third base and pitcher beginning with the 2018 season.

#### **Review Track/Field and Cross Country Alignment Feedback and Adopt Final Alignment for 2017-18 through 2020-21 Seasons**

A draft alignment had been presented to the membership for review with input from the schools reviewed and any necessary adjustments recommended in order that the Board give final adoption to the alignment.

#### **Consider Harlan County Appeal of Placement**

Harlan County had appealed the enrollment figures used to place them in Class 3A in the alignment. Previously, for 2015-16, Harlan County presented a similar appeal.

Commissioner Tackett noted that even with the elimination of the 42 students in 2015-16 and 49 students in 2016-17 from the enrollment numbers (due to Appalachian Challenge Academy), Harlan County would remain in the top 30% of the schools, to remain in class 3A.

**Motion Passed:** Consider the request including the removal of the Appalachian Challenge Academy students, however deny the request for movement due to the fact that the school continues to be in the top 30% of enrollment passed with a motion by Debbie Beichler and a second by Trent Lovett. #### **Consider revision to competition rules, Cross Country State Meet qualification**

Through the alignment discussion with member schools, some suggestions have been made which would move schools out of their proper geographic location solely for the purpose of ensuring qualification to the Cross Country State Meet in spite of potential balancing of the number of teams and competitors in track and field meets within the alignment.

Currently the procedure to qualify for Cross Country is as follows:

1 full team with all entrants meeting the four meet minimum that enters the regional meet. 1 team advances

2 or 3 full teams with all entrants meeting the four meet minimum that enter the regional meet. 2 teams advance

4 to 6 full teams with all entrants meeting the four meet minimum that enter the regional meet. 3 teams advance

7 to 9 full teams with all entrants meeting the four meet minimum that enter the regional meet. 4 teams advance

10 to 12 full teams with all entrants meeting the four meet minimum that enter the regional meet. 5 teams advance

13 or more full teams with all entrants meeting the four meet minimum that enter the regional meet. 6 teams advance

After the qualifying teams are determined, the top 5 individuals not on qualifying teams will advance to the State Meet as "Individual Qualifiers"



Only those who have met the four meet minimum, and those that enter a valid team, will count towards the number of teams entered.

The Commissioner and staff are recommending this be changed to the following-

1 full team with all entrants meeting the four meet minimum that enters the regional meet. 1 team advances

2 or 3 full teams with all entrants meeting the four meet minimum that enter the regional meet. 2 teams advance

4 to 5 full teams with all entrants meeting the four meet minimum that enter the regional meet 3 teams advance

6 to 7 full teams with all entrants meeting the four meet minimum that enter the regional meet. 4 teams advance

8 to 10 full teams with all entrants meeting the four meet minimum that enter the regional meet. 5 teams advance

11 or more full teams with all entrants meeting the four meet minimum that enter the regional meet. 6 teams advance

After the qualifying teams are determined, the top 5 individuals not on qualifying teams will advance to the State Meet as "Individual Qualifiers"

Only those who have met the four meet minimum, and those that enter a valid team, will count towards the number of teams entered.

This will allow the consideration of the alignment to focus on geography and not cross country competitor numbers.
