## Definitions

E01 Student enrolled for first time during the current year in either a public or nonpublic school in the US
E02 Student previously enrolled during the current school year in either a public or nonpublic school in another state and not previously enrolled in Kentucky during the current school year.
E03 Student enrolling for the first time this school year who withdrew as a W24 or W25 for previous year.
R01 Student received from another grade in the same school or change in schedule structure.
R02 Student received from another public school in the same public school district.
R06 Student reentering school after dropping out, discharge or expulsion from a school district in Kentucky during the current school year, who has not entered any other school during the intervening period.
R20 Student previously enrolled in a home school in Kentucky during the current school year.
R21 Student previously enrolled in any public or nonpublic school (excluding home schools) in Kentucky during the current school year.
Withdrawal codes:
W01 Student transferred to another grade in the same school or change in schedule structure.
W02 Student transferred to another public school in the same public school district.
W12 Student under the jurisdiction of the court and cannot substantiate enrollment in educational program. Considered a Dropout.
W20 Student transferred to homeschool.
W21 Student transferred to nonpublic school (excluding home school).
W22 Student transferred to another public school in KY and for whom a request for student records has been received or enrollment has been substantiated.
W23 Student who withdraws for the second time who initially withdrew as a W24 or W25 during the current school year. Considered a Dropout.
W24 Student who has moved out of this public school district for whom enrollment elsewhere has not been substantiated. Considered a Dropout.
W25 Student who is above the minimum age for withdrawal. Considered a Dropout.
W26 Student who withdraws after completing a secondary GED program and receiving a GED certificate.
W27 Student who has withdrawn from school and subsequently received a GED.
W28 Student who has reached the maximum age for education services without receiving a diploma or certificate of attainment. Considered a Dropout.
W29 Student who has moved out of state or the United States.
W30 Student with an IEP enrolled in Grade 14 who has previously received an alternate high school diploma, re-enrolled, and withdrew in the middle of the reporting school year.
