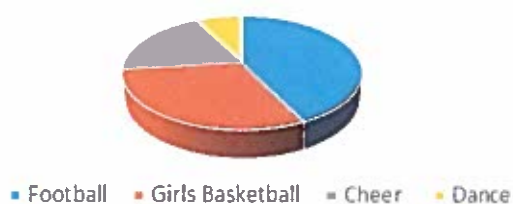
There were seven middle school student's ineligible because of academics and no student athletes were withheld from athletic participation because of attendance during fall sports.
