Dear Mr. Watts:

On behalf of the PRIDE Board of Directors, I am pleased to award \$2750 for your PRIDE environmental education efforts at the following school(s) in your district: Breathitt High School: \$2750. A copy of your approved grant budget is attached. Approval of your grant award is contingent upon you agreeing to the contractual terms set forth in this Letter of Agreement. For purposes of this Agreement, You, Your, or Grant Recipient(s) refer to obligations that your organization must comply with in order to receive the award.

- Your award may come with stipulations. You will also find those listed on the "Approved Budget" attached. Please review those stipulations and, if you approve, please sign and return the "Approved Budget" page along with this signed Award letter.
- 2. Your award amount is based on the approved grant "Budget" for each school and is attached to this Letter of Agreement. Funds provided to You pursuant to this Letter of Agreement are to be used solely for the line items set forth in Your Budget.
- 3. Your assigned Grant Number is EEG-17-003. This number **must** be included on all correspondence regarding this grant.
- 4. The grant period is October 1, 2017 to May 31, 2018 ("Grant Period"). All costs incurred prior to the grant award date (October 1, 2017) and after the last day to spend funds (April 30, 2018) will be disallowed.
- PRIDE funds awarded under this grant cannot be used to generate income during the Grant Period.
- 6. Funds are provided to You on a reimbursable basis only. Requests for Reimbursement must conform to the line item Budget approved by PRIDE and attached to this Letter of Agreement. The attached Request for Reimbursement form, along with detailed invoices or

- 7. Prior to submitting a Request for Reimbursement, all public schools are required to submit a copy of their MUNIS Project Budget Report that shows the contract has been set up in MUNIS.
- 8. At a minimum, You must match 20% of the PRIDE grant award. When calculating labor reported as in-kind match, a rate of \$20.00 per hour is used for volunteer hours. Actual hourly rates of pay may also be used if supported in writing with an Authorized Signature (See Section 11 below). Hourly rates cannot include an amount equal to the cost of fringe benefits.
- 9. PRIDE cannot reimburse for teachers, substitute-teachers or other school employee's salaries; however, their salaries (excluding any amount for fringe benefits) may be used as an in-kind match.
- 10. All paperwork submitted to PRIDE in connection with this grant award must be signed with an authorized signature or an alternate authorized signature ("Authorized Signature"). An Authorized Signature may be the school principal, superintendent, or director of a non-profit organization. Each authorized signor may designate one additional alternative authorized signor. Both individual's names and signatures are needed on the ACH Transfer Information Form.
- 11. The following forms must be signed and returned to the PRIDE Office prior to submitting a Request for Reimbursement:
 - ACH Transfer form
 - Letter of Agreement Signature Page
 - CD-512 (Lobbying Form)
 - Conflict of Interest Statement
 - Statement of Policies
- 12. You are required to submit a Progress Report #1 on December 31, 2017, and Progress Report #2 on March 30, 2018. The PRIDE Education Grant Progress Report Form is attached.

 Reimbursements will not be made if Progress Reports are delinquent. Grant Recipients with delinquent Progress Reports for more than 30 days are automatically reassigned to Risk Assessment C.
- 13. You agree to comply with Executive Order 11246, as amended by Executive Order 11375, which states Grant Recipients may not discriminate on the basis of race, sex, religion, color or national origin. Grant Recipients must take affirmative action to ensure that equal opportunity is provided in all aspects of employment.
- 14. You agree to maintain records for a minimum of three years after project completion, as specified in OMB Circular A-102, Section .42, "Retention and Access for Records" and

- 2CFR Part 215, Section .53, "Retention and Access Requirements for Records". PRIDE shall have access to the records at all times. All documentation pertaining to this grant must be kept in a project file and be available during any site visits.
- 15. These funds are intended for the sole purpose of providing environmental education. You may maintain residual inventory or excess supplies for use on non-Federal sponsored activities or sell them, but shall in either case, compensate PRIDE for its share. The amount of compensation shall be calculated by applying the percentage of PRIDE participation in the cost of the original project to the current market value.
- 16. The terms and conditions of this grant award may only be amended upon PRIDE's written approval.
- 17. Your Risk Assessment is A. Depending on Your assigned Risk Assessment, You may also be required to comply with the conditions set forth in Section 7 of the PRIDE Education Grant Compliance Manual, which Manual is incorporated into this Letter of Agreement as if fully stated herein. Please note that all Grant Recipients evaluated to be Risk Assessment C are required to submit copies of all cancelled checks along with their reimbursement requests.
- 18. A Final Report is due within 30 days of completion of the project or May 31, 2018, whichever is sooner. Field inspections of approved projects may take place periodically. A copy of the PRIDE Environmental Education Final Report is attached.
- 19. If for any reason You are unable to carry out grant activities, PRIDE will not transfer grant funds to another organization. All awarded, but unused, grant funds revert back to PRIDE.
- 20. Grant Recipient covenants and agrees to take, use, provide and make all proper, necessary and sufficient precautions, safeguards and protections against the occurrence or happenings of any accidents, injuries, damages or hurts to any person or property during the progress of the work herein covered, and to be responsible for and to indemnify and hold harmless PRIDE from the payment of all sums of money by reason of all or any accidents, injuries, damages or hurt, that may happen or occur upon or about such work and all fines, penalties and loss incurred for or by reason of the violation of any local, city, or county ordinance or regulation or by the law of the Commonwealth of Kentucky or United States while the work is in progress.
- 21. This grant award is governed by OMB Circular 2CFR Part 215. You agree that these provisions are controlling with respect to this grant.
- 22. Since it is of the utmost importance that PRIDE becomes synonymous with responsible environmental projects, You agree that all printed materials regarding this project must include the PRIDE logo or recognize that funding for such print was made possible through PRIDE. All printed materials must first be approved by PRIDE.

This Letter of Agreement is a binding document. Failure to comply with the covenants and stipulations listed in this Letter of Agreement and the Compliance Manual, which is incorporated in its entirely herein, may result in immediate forfeiture of all funds awarded under this grant. PRIDE may terminate the grant award at any time in its sole discretion if You do not comply with the terms of this Letter of Agreement. In addition, PRIDE reserves its right to pursue all legal and equitable remedies available to it under Kentucky law to enforce its rights under this Letter of Agreement.

This program is funded in part by a grant from the Appalachian Regional Commission. The Catalog of Federal Domestic Assistance (CFDA) Number is 23.002 Appalachian Area Development.
