Students identified with mild to moderate disabilities 16 years of age and older will tour Carl D. Perkins campus in Thelma, KY. The C. Perkins Center provides several types of programs and services to help persons with disabilities achieve competitive integrated employment, and maximize daily living independence.

- Met w/John Windslow Northern Kentucky Education Cooperative's Low Incidence Consultant specializing in identifying educational needs of student's w/Autism diagnosis.
 Mr. Windslow will be supporting preschool teachers at NPS by providing student specific recommendations needed to promote school success.
