VII.A. Job Descriptions for Arts Educators

Rationale:

Northern Kentucky Institute for Arts Education will build a comprehensive system of professional development support for 20 teams of six educators each (120 teachers total) from schools that have 50% of students who come from low-income families. The goals of NKIAE are 1) To implement a high-quality model professional development program for arts educators and other instructional staff that enriches the academic experience by promoting arts education for students, including disadvantaged students and students who are children with disabilities and 2) To deliver professional development supports that increase the capacity of arts teachers to serve as interdisciplinary education leaders in Northern Kentucky schools. Objectives include: 80% of 120 participants on 20 interdisciplinary teacher teams will participate in sustained and intensive arts integration professional development. 75% of participating teachers will show statistically significant improvement in arts content knowledge. 75% of participating teams will implement collaboratively designed arts integrated units. 50% of participating teams will conduct at least one unit involving standards-based integration of arts and another content area that is rated "accomplished" or higher. 30% of participants will take on new leadership roles after their first year of participation. Technology use is infused throughout the project: teachers will be required to use technology in preparation for the summer workshop, during the workshop, and throughout the year to support their arts integration work; to participate in online professional learning communities; to obtain online professional development monthly through the project's professional learning network; and to post units on the project's online sharing platform.
