POLICY STATEMENT
<p>Criteria for Programs</p> <p>For an extracurricular program to be continued or to institute a new program, the program must:</p> <p>Contribute to the following Kentucky Learning Goals:</p> <ul style="list-style-type: none">• Becoming a self-sufficient individual.• Becoming responsible members of a family, work group, or community, including demonstrating effectiveness in community service. <p>Generate and maintain student interest as well as attract students currently not involved in extracurricular or service projects.</p> <p>Encourage, enhance, and maintain equity including but not limited to a wide range of opportunities for both male and female students.</p> <p>Have a suitable adult sponsor and have appropriate adult supervision at all times.</p> <p>Programs currently offered:</p> <ul style="list-style-type: none">• Volleyball• Golf (B/G)• Track (B/G)• Cross Country (B/G)• Basketball (B/G)• Baseball• Softball• Cheerleading• Band (Pep Band)• Academic Team• Bass Fishing (B/G)• Any other extracurricular activity excluding project P.A.S.S.

Student Participation

“Active Participation” will be defined as: engaging in practice or playing in a contest

Students will be eligible to actively participate in extracurricular activities if they:

- Were in attendance on the day of the activity (student must be present for at least 75% of the school day) or on Friday for weekend activities.
(Excused absences may be granted at administrator’s discretion).
- Comply with the rules established by the adult coach or sponsor of the activity.
- Meet the requirements set by the appropriate sponsoring or governing organization. (KHSAA)

Coaches and Sponsors

Each extracurricular activity will be led by an adult coach or sponsor who meets any applicable requirements set in law, or by sponsoring or governing organizations. The coach or sponsor will be responsible for personally or supervising or ensuring that all students are supervised by an adult while they are participating in an activity, including practice time and travel time where applicable. The coach or sponsor will also be responsible to make sure the students are meeting the guidelines to participate.

Eligibility

Determination of athletic eligibility shall be made in compliance with Kentucky High School Athletic Association requirements. Coaches at the High school and middle school levels in consultation with the athlete’s parents, athletic director, and administrators will determine the most appropriate settings based on the students ability, maturity, and the needs of the overall program.

We will evaluate the effectiveness of this policy through our School Improvement Planning Process.
