Consent Agenda Item (Action Item): Betsy Layne High School Anthropology Club is requesting permission to travel to New Orleans, Louisiana via Tomblin Tours from April 29-May 3, 2018 for a summer travel experience.

Applicable Statute or Regulation: Board Policy 01.11 General Powers and Duties of the Board of Education

Fiscal/Budgetary Impact: The price is all inclusive and will be covered entirely by the Betsy Layne Anthropology Club and its members.

History/Background: Anthropology Club was created in the 2016-2017 school year based on student interest and need. The majority of our students come from low income families and lack opportunities to travel within the continental United States. Many of our students have not travelled outside of Appalachia and lack variety in their cultural experiences and understanding. This trip, and the ones that follow, will make our students global citizens and provide them with the experiences necessary to be successful in college and all careers.

Recommended Action: Floyd County Board of Education allows Betsy Layne High School Anthropology to travel to New Orleans for a musical, culinary, historical, and ecological experience.
