## Vacancy for Superintendent

The Floyd County Board of Education is seeking an outstanding educator with the leadership skills capable of extending the momentum of excellence of Floyd County Schools. The successful candidate must be student-centered, an advanced communicator, and demonstrate a commitment to high expectations and performance. Along with a record of raising student achievement, candidates should also possess a background of successful financial management in times of declining revenues.

The fiscally sound Floyd County School district is one of the major education reform success stories in Kentucky. The district, at one time under state management in the 1990's, has showed outstanding improvement over the past several years, having been named a Kentucky District of Distinction each year since 2013. The district transports the majority of its students each day with over 5400 miles traveled by the school bus fleet.

Floyd County, located in the scenic mountainous area of eastern Kentucky, consists of 396 square miles and has a population of approximately 37,000. The county seat is Prestonsburg, which is located between Pikeville and Paintsville. The area prides itself with the location of Jenny Wiley State Park with 1,700 acres, a lodge, cottages and 700 seat convention center. The Mountain Arts Center in Prestonsburg hosts a variety of performers and audiences from across the state with seating for over 1,000 people. The county also boasts the renowned Stonecrest golf course, one of the most challenging courses in Kentucky.

The Floyd County Chamber of Commerce provides support for area businesses and for community growth. Approximate mileage to some of the metro areas: Lexington-120, Louisville-180, Cincinnati-190, and Knoxville-200.
