1. Tour Operator is authorized to arrange FRONTIER round trip air as follows:

4/26/18	Flight # 1619	Depart Cincinnati (CVG) at 6:00AM	Arrive Orlando (MCO) at 8:21AM
4/30/18	Flight # 1616	Depart Orlando (MCO) at 8:15PM	Arrive Cincinnati (CVG) at 10:35PM

Airline and Departure times are subject to final schedule
2. Group price for air only is \$299.00 per seat including tax, in effect as of October 23, 2017. Please note price is based on current jet fuel and is subject to any fuel related increases or taxes not in effect as of October 23, 2017, which are passed on by the airline no later than 21 days prior to the departure.
3. Group airfare is based on a minimum of 10 paid passengers. If you reduce to fewer than 10 people after signing this group air contract, penalties would apply that would result in loss of deposit. This may result in booking as individual reservations and subject to different pricing.
4. Payments shall be made by the Agency as follows:
 - A. \$55.00 per person NON-REFUNDABLE deposit by November 13, 2017, to hold space along with signed contract.
