Dear Supt. Stanley and Members of the Board,

As I have indicated during past board meetings, the retrofit light fixture that was specified for the auditorium project would not work and we need to do a fixture replacement. However, in doing so, there is an increase in both the project scope and cost. The following will outline the issue and the fix.

When we bid the project, we received three bids; the lowest being submitted by Dezyne, Inc., in the amount of \$37,910. Dezyne was \$14,830.00 lower than the second best bid (see attached Bid Tabulation).

The project was bid as a fixture retrofit. Once under contract, thankfully Dezyne wanted to install one fixture so they would have a better idea on how best to complete the project. In doing so, it was determined that the retrofit fixture's "compression spring would not fit properly in the existing fixture".

I am under the impression that Dezyne worked with the lighting manufacturer and tried 3 other retrofit fixtures and none of them would properly fit in the existing light fixture. Therefore, we have asked Dezyne to do a complete fixture replacement which, in our opinion, is a better solution.

Dezyne is asking for an additional \$6,389.00. If approved, this is still \$8,441.00 under the second best bid.

If acceptable, these fixtures will be installed over a two week period, starting on Wednesday, March 28th and being completed on April 10th.
