AN ORDINANCE AMENDING THE CITY OF MOREHEAD, KENTUCKY
CODE OF ORDINANCES, TITLE 11, BUSINESS REGULATIONS,
CHAPTER 113, ALCOHOLIC BEVERAGE CONTROL SECTION 113.08(J), HOURS
FOR SALE AND CONSUMPTION OF THE CITY OF MOREHEAD
CODE OF ORDINANCES TO PERMIT SALES
BY RESTAURANTS AND BARS UNTIL 1:00 A.M.

WHEREAS, the City desires to extend the hours that restaurants or bars may sell alcohol by the drink;

NOW, THEREFORE, BE IT ORDAINED by the Board of City Council of the City of Morehead, Kentucky that Title 11, Business Regulations, Chapter 113 Alcoholic Beverage Control, Section 113.08(J), Hours for Sale and Consumption shall be amended as follows:

Section 113.08 Hours for Sale and Consumption

(J) Hours for sale and consumption.

(1) ~~[No licensee, unless permitted herein]~~ Retail package distilled spirits, wine and malt beverages licensees shall ~~[sell alcoholic beverages]~~ be permitted to sell Monday through Saturday at all hours except for the period between the hours of 12:00 midnight and 6:00 a.m. prevailing time, and on Sundays between 12:00 midnight and 12:00 p.m.

~~[(2) Licensees may sell distilled spirits, wine and malt beverages by the package from 12:00 p.m. to 12:00 midnight.]~~

~~[(3)2] [Restaurants may sell distilled spirits, wine and malt beverages]~~ A licensee for distilled spirits, wine and/or malt beverages by the drink shall be permitted to sell or dispense alcoholic beverages by the drink Monday through Saturday, from 6:00 a.m. to 1:00 a.m. of the following day, and on Sunday from 12:00 p.m. to 1:00 a.m., on Monday, provided that the appropriate licenses and approvals have been obtained from both the city and the state ABC Board.

~~[(4) Any licensee shall, on New Year's Eve, December 31, be permitted to sell alcoholic beverages until 1:00 a.m. on January 1.]~~

(3) Consumption of alcoholic beverages on licensed premises may not continue for more than thirty (30) minutes after the respective hours set forth herein for sales to stop.

~~[(6) If Sunday drink sales are permitted by this section, licensees must first obtain a Sunday retail drink license in order to sell distilled spirits and wine by the drink on Sunday.]~~
