### I. Call to Order

Vice Chairman Ann Carty called the meeting to order at approximately 6:04 pm.

He commended the maintenance and custodial staffs from throughout the district for their efforts to clean and restore the conditions back to order for the students.

### **IV. Action/Discussion Items**

### A. FRYSC Coordinator Position

Superintendent Green explained that due to the retirement of the current FRYSC Coordinator as of January 1<sup>st</sup>, this vacancy would need to be posted immediately. Mr. Green also explained that by changing this from Coordinator I to a Coordinator II, which raises the requirement for this position from a high schools diploma to a Bachelor's Degree, it would allow the position to contribute to KY Teachers' Retirement. By doing this, it would save the district approximately \$8,000 based on current year retirement rates and \$12,500 for the next fiscal year due to matching increases. This not only would allow the

district to receive higher qualified applicants, but also produce a financial savings. Superintendent Green noted that the salary and contract days would remain the same, just a change in the level of the position based on KDE job descriptions.

**Order #1492 - Motion Passed:** Approve FRYSC Coordinator I position at 240 days to become FRYSC Coordinator II at 240 days with no change in salary passed with a motion by Mrs. Ashley Brown and a second by Mr. Forrest Beeler.

### **B. 2016-2017 Audit Report**

The 2016-2017 Audit Report was presented by Mr. Artie White, CPA. He noted that Pikeville Independent was given an unmodified opinion on the overall audit which is the highest rating to be given. There were no findings at the district level and minor findings at the school level. Mr. White expressed his confidence in the financial audit and the strength of internal controls for the district.

**Order #1493 - Motion Passed:** Approve 2016-2017 Audit Report passed unanimously with a motion by Mr. Forrest Beeler and a second by Mrs. Ashley Brown.

Superintendent Green shared an e-mail from Architect Scott Jackson containing a revised BG-1 form to be approved and submitted to KDE for the PHS Canopy/Flag Pole Project. This revision was simply needed to reflect the updated amounts now that the construction bids had been received. Mr. Green recommended approval of the revised BG-1 as presented.
