SUPERINTENDENT'S CONTRACT CONTRACT FOR SECRETARY OF BOARD OF EDUCATION [BOARD POLICY 02.1311]

COMMONWEALTH OF KENTUCKY COUNTY OF LIVINGSTON SMITHLAND, KENTUCKY 42081

This "Article of Agreement" made and entered into this the 22 day of January, 2018, to wit:

WITNESSETH: That Victor Zimmerman of 739 Dendy Road, Grand Rivers, Kentucky 42025, holding a certificate in administration and supervision, as provided by KRS 160 et seq. and as recorded below, hereby contracts with the Livingston County Board of Education of Smithland, Kentucky, as Superintendent of Schools of said District for a term of Four (4) years beginning on the 1rst day of July, 2018, and expiring on June 30, 20 27, in accordance with the Kentucky Revised Statutes, the Common School Law and the Rules and Regulations prescribed pursuant thereof by the State Board of Education. NOTE: Specific reliance is placed on Board Policy #02.1311 as provided to and adopted in its entirety by the Livingston County Board of Education as given by the State Board of Education.

IT IS AGREED that Victor Zimmerman shall receive an annual salary of per year, with raises to be per year, with raises to be given annually at an equal percentage to those given other certified personnel to be paid in regular monthly installments out of the school fund of said District. Said District shall pay all professional dues during the life of this Agreement to KASS, AASA and KASA. Said District shall pay for insurance liability coverage for the

Superintendent during the life of this Agreement with limits equal to what is in place at this time and paid for by the District. In the event no such coverage is provided by the District at this time, the District shall provide coverage limits equal to what other providing Districts of equal size provide to their Superintendents during the life of this Agreement.

IT IS FURTHER AGREED that Superintendent's work year shall consist of not less than Two Hundred and Forty (240) days and that Superintendent is to devote his entire time to the discharge of his duties as set out by law, rules and regulations of the Commonwealth of Kentucky and the State Board of Education and the Livingston County Board of Education, and that failure to do so will invalidate this Agreement.

The Certificate for Victor Zimmerman for certification as a School Superintendent is No. 200236149 issued on 07/01/2006 and continuing.

The said District further contracts with Victor Zimmerman to serve as Secretary of said District Board of Education for a period of <u>Four (2)</u> years beginning on July 1, 2018, and expiring on June 30, 20<u>72</u>, as is authorized by KRS 160.440. It is agreed there shall be no additional compensation other than the above-stated and further Superintendent shall perform his duties in the same manner as heretofore stated.

This Contract is conditioned on the fact that Superintendent has no criminal record.
