If this contract is not returned with the agreed upon deposit within seven (7) days, or you fail to call, the mentioned DJ/Artist may not be available. Self Diploma will contact you when your contract is received. (If you are not contacted, call Self Diploma) The agreement of Self Diploma and the client to engage their services is subject to proven detention by sickness, accident, death or acts of God. In the event of emergency with contracted DJ/Artist, Self Diploma can provide client with a backup DJ/Artist with written approval from the purchaser; otherwise, purchaser may cancel the scheduled performance and forfeit their deposit. If date is verbally cancelled or changed by client, client must give written notice immediately to Self Diploma and client forfeits deposit. If cancellation occurs within 14 days prior to event date, the balance is to be paid in full to Self Diploma by the Event Date listed in this agreement. Client shall indemnify Self Diploma for any damage done to equipment, except when done by Self Diploma. Self Diploma acts only as an agent for the DJ/Artist and assumes no liability thereunder.
