The film and interview footage will be used in educational and promotional means for the Dave Ramsey organization.

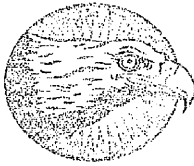

LOCATION RELEASE

I grant to LAMPO GROUP, INC. LAMPO agrees to hold harmless and indemnify the undersigned from all claims, demands, causes of action, damages, liabilities of any kind, and reasonable attorney fees which may arise out of or in connection with any property damage caused by LAMPO while taping at the Location Address. I release and agree to hold harmless and indemnify LAMPO, its licensees and assigns from all claims, demands, causes of action, damages, liabilities of any kind, and reasonable attorney's fees which may arise out of or in connection with the use of the Recordings.

I represent and warrant that I am the sole owner (or sole owner's authorized representative) or the sole lessee (or sole lessee's authorized representative) of the property at the Location Address below and have the right, power and authority to grant the rights set forth in this Location Release. This Location Release represents the entire understanding in effect between the parties.
