PRICING AND EXPIRATION: This Agreement guarantees the pricing for 6 months for the software license and professional development, conditioned upon Customer's commitment to a 6-month initial subscription beginning on the Subscription Start Date (the "Initial Term"). This Agreement also confirms the pricing for any custom services in any attached Statement of Work. Notwithstanding anything to the contrary in this Agreement, if this Agreement is not executed by Customer on or before February 28, 2018 the terms and conditions set forth herein (including those related to pricing) shall become null and void.

PAYMENT TERMS: Pricing for the software license and professional development above reflects current Customer enrollment. If this Agreement is longer than 12 months, Customer agrees to pay for any increase in student enrollment for subsequent years. All prices above in USD. All payment obligations are non-cancelable and all amounts paid are nonrefundable. MasteryConnect shall be entitled to withhold performance and discontinue service until all amounts due are paid in full. Payment is due upon Effective Date, unless otherwise specified below.

OVERDUE CHARGES: If payment for any invoiced amount is not received by MasteryConnect by the due date, then without limiting MasteryConnect's rights or remedies, those charges may accrue late interest at the rate of 1.5% of the outstanding balance per month, or the maximum rate permitted by law, whichever is lower.

TERMINATION FOR NON-APPROPRIATIONS: Customer may terminate this Agreement prior to the expiration of the Term with respect to any services for which Customer does not receive appropriations if Customer delivers to MasteryConnect a written termination notice within 30 calendar days of the beginning of the calendar year for which Customer did not receive such appropriations, specifying the services for which Customer did not receive appropriations and including evidence of Customer's failure to receive such appropriations. In such case, Customer shall be required to pay only for the

terminated services through the date of Customer's delivery of such written termination notice to MasteryConnect; however, if Customer purchases at any time prior to the expiration of the Term (before giving effect to early termination pursuant to this paragraph) services that are the same as or similar to the services terminated pursuant to this paragraph, Customer shall be required to pay MasteryConnect for the terminated services as if they had been provided until the expiration of the Term (before giving effect to early termination pursuant to this paragraph).
