A. School Safety Presentation

Superintendent Green introduced Commissioner of Public Safety Phillip Reed and Police Chief Chris Edmonds to present an overview of the services provided by the Pikeville City Police Department. Chief Edmonds explained that the department provides an officer on each campus for at least two hours each day especially during mornings and afternoons. They also assist in all safety drills and monitor the buildings security daily. He also stated that additional trainings will be conducted with staff and parents to educate them on what to expect during an emergency lock down.

B. FRYSC Continuation Program Plan

DPP Billy Johnson presented the Continuation Program Plan for the Family Resource Youth Service Center. The plan addresses programs of focus for the program in the future. Mr. Johnson noted this plan requires board approval for the program to continue for fiscal years 2019 and 2020.
